Notification and Enforcement of MAP Violation

Pharma Supply, Inc. will notify reseller of the MAP violation immediately upon becoming aware of said violation. If the violation has not been corrected within 24 hours of notification, Pharma Supply, Inc. reserves the right to terminate the reseller as an Authorized reseller and stop providing the vendor with the any further products. Pharma Supply also has the right to terminate a reseller for multiple violations of MAP, even if they are corrected promptly upon notification.

In addition, Pharma Supply has the right to limit shipments of large orders into smaller shipment increments for the purpose of preventing a subversion of MAP pricing by tactics such as "loss leaders" "gaining the (Amazon, etc.) buy box", etc. In these instances Pharma Supply will honor the quantity pricing for the entire amount, bill for only the amounts when shipped and Pharma Supply will pay shipping of the subsequent partial shipments until the full quantity has been shipped.
